- Suitable eye protection: goggles.
- Hand protection:

## 9. Dosage Instructions

- Reference dosage for window cleaning to remove normal dirt: 1%. Dilute 1:100. Corresponds to 40 ml in 4 liters of water or 10 ml in 1 liter of water. If the dirt is more severe, it is recommended to repeat the cleaning. If the dirt is more severe/lighter, the dosage can be increased/adjusted accordingly. Lighter dirt: dilute up to 1:1000 (4 ml in 4 l of water). Stubborn dirt: 1:20 (200 ml in 4 l of water). Basic installation guidelines (if applicable).

- Requirements for storage rooms and vessels
  - Keep container tightly closed. Keep in a cool, well-ventilated place.
- Suitable floor material:
  - Acid-resistant.

  - No special measures are necessary.
